The integrity of the UK criminal justice system has fallen into 'Kangaroo Court' style persecutions due to the 'I believe you' edict of sexual abuse allegations. The 'I believe you' edict of our justice system must be reversed and replaced with objective and neutral investigation. Even juries are told by judges to 'believe' what is obviously untrue because of these crude and archaic guidelines, resulting in miscarriages of justice and innocent people imprisoned.

Rolf Harris was tried at Southwark Crown Court enduring four trials at once. There were four accusers and a total of twelve charges.

Tonya Lee had already sold her story to a magazine so had a financial interest in sticking to the already published story. In court the story was shown to contain serious falsehoods and she admitted that she lied to the police. Despite this Mr Harris was found guilty.

The alleged Leigh Park community centre assault was alleged to have been done at a time when Mr Harris was in fact in another part of the country, and this can be easily proved. A police search for evidence that Mr Harris had appeared at the community centre at this time confirmed that he had never appeared there at all. The police admitted in court that they had NO EVIDENCE that he had even been there, but despite this Mr Harris was found guilty.

The Cambridge celebrity It's a Knockout allegation was made by a woman who claimed she was thirteen/fourteen at the time of the assault. The assault happened in public and yet nobody saw it happen. Mid trial she changed this story to fit an appearance Mr Harris had made at a Star Games event, three years later. She changed her age to sixteen/seventeen and the location miles away from the site of the original allegation. Despite this Mr Harris was found guilty.

Mr Harris admitted a consensual affair with a woman younger than him but of consenting age. It was shown that this woman had attempted to blackmail him after asking him for £25000 and there was no evidence to show that any under age abuse took place as she later claimed. Despite this Mr Harris was found guilty.

Mr Harris was convicted of all twelve counts after the jury were told by the trial judge to 'recognise a RED HERRING when you see one and ignore it'; but the prosecution barrister had told the jury in her closing speech that Mr Harris' explanations and denials were RED HERRINGS. Was the judge summing up on behalf of the prosecution by effectively telling the jury to ignore Mr Harris denials and explanations? This was a gross burden of bias given to the jury by the trial judge who was supposed to have summed up impartially.

Criminal justice must be based on truth and not the 'I believe' edicts that allows any person to make any claim of abuse against any person and be believed; with cases

going to court despite there being evidence contrary to the claims and the resultant miscarriages of justice.

Mr Harris has been denied a right to appeal and this travesty of justice must be urgently reviewed and his right of appeal allowed.

He thanked his legal team, led by Stephen Vullo QC, for "finally" proving his innocence of the alleged crime, which he said was backed up by a "fantasist" claiming to be the sole witness. He added: "I hope the press supply the facts to the public to let them decide if I am a monster or the subject of a frenzied witch hunt which focused more on grabbing headlines than finding the truth."



Yesterday (30 May 2017) Rolf Harris was cleared of four charges of indecent assault after a jury could not reach verdicts in a retrial in Southwark Crown Court. 

People who make allegations have been instantly termed "victims" and the sense of innocent until proven guilty has been wholly abandoned in these cases. Juries convict on the basis of no smoke without fire, and where there is no hard evidence at all. Particular groups of people such as teachers and carers and those who were once employed within institutions are particularly vulnerable. Legal aid provides a solicitor with little remuneration, so they more naturally focus on their high fee paying clients. Many are coming out of court appalled at what they consider a total lack of proper representation. Even where the representation is good, it would seem many in the jury have a cognitive bias towards guilty and a fear of letting a possible paedophile loose. The number of false allegations are like confetti in some areas, and the police conduct an enquiry purely with a view to getting a conviction, rather than following up anything which could possibly help the accused. People can be repeatedly bailed over years, by which time their lives are seriously impacted even if eventually no further action is taken. Ultimately the way this is being dealt will produce a two fold tragedy; families destroyed by false allegations and the real victims back to square one, where they are afraid to come forward for fear of not being believed. It is vital that we see real justice here instead of the absolute travesty we are witnessing at present. Some people are liars, some want attention or drama, some want someone to blame for their disastrous lives and others really believe it happened, when their memory is impacted for whatever reason. We must take an evidence only based approach, and publicly achieve a balanced attitude towards these matters, because the public frenzy following Savile has created a total imbalance. Child abuse is totally abhorrent, and must be eliminated. However this will never be achieved with the present approach which has reduced our system of justice to something we should all be ashamed of. People like Harvey Proctor have been hounded to death, and his book makes grim reading. One day the full extent of all that has gone wrong here will be revealed. The problem then is that the real victims will go silent again.

Although not having read the details of the case, from what has been reported so far there seems to be far too much room for doubt and the verdict seems to be one more about personal moral discomforts rather than actual hard evidence.

A few examples:

- 1. The alleged abuse of Bindi's friend isn't believable. The woman in question continued her relationship with Rolf until her early 20's. So even if she had been "abused" at an earlier age, the fact that she did not terminate the relationship until well into adulthood means that her testimony is worthless.
- 2. The disproportionate allegations of "groping" or inappropriately "touching" young women (and allegedly an 8-year-old) seem so inconsequential as to make the rest of the case ludicrous. A celebrity will be in physical contact with fans, often involuntarily, so any inadvertent touching can be misconstrued. Of the THOUSANDS of people he's been in contact with over the years, ONLY a very few allegedly had these experiences. A sexual predator would have had countless victims and the abuse would have been far more severe (and more private).
- 3. The fact that Rolf was found guilty of an allegation where there is good evidence to show that HE WASN'T THERE at the time is exceedingly disturbing.

The above examples could be simply due to misreporting.

However, I have personally experienced a concerted attempt by police and Local Authority professionals to smear me and pin any kind of serious offence on me - by creating false evidence and perjury in court. (With impunity, it turns out, because when my barrister ascertained that the witnesses lied or manufactured evidence, there was NO prosecution of the guilty parties, not even "contempt of court"!)

Having experience so-called "British Justice" at first hand, I realise now how easy it is to convict an innocent person, or at least anyone who might be possibly guilty but without satisfyingly clear evidence.

I've had to prove my innocence on a number of occasions in the case against me, which of course is almost impossible to do - but luckily I was able to do so on each count because I was able to obtain copies of documents that had been conveniently

'mislaid' by the police and official witnesses. It turns out that even proof of my innocence wasn't enough and I still had to undergo several months of 'observation' before being begrudgingly cleared of the various malicious allegations made against me.

I can't imagine what someone like Rolf had to go through, particularly as no-one is squeaky clean or the paragon of virtue. No doubt the prosecution felt that if you throw enough mud at the man, some of it will stick. And so it did!

What is most alarming about this case is that nothing he is alleged to have done seems particularly serious. They weren't "assaults", at worst he behaved crudely, but none of the allegations seems to indicate he was a serial rapist and child molester.

Even if Rolf had committed some of these acts, the evidence doesn't seem strong enough ("beyond a reasonable doubt") and the conviction seems to be unsafe at all levels, and that is the most worrying aspect of this case.

I entirely agree the evidence must be subject to lawful disclosure, be substantiated on a stand alone basis and brought case by case.

The Government funded Criminal Injuries Compensation Scheme 2012 muddles the waters still further. This Scheme provides compensation for any individual who brings a claim of sexual assault regardless of conviction. Yes "regardless of conviction". There is a tariff of injuries and the Criminal Injuries Compensation Authority (CICA) administers each claim.

It is not surprising to learn that there are now more and more alleged victims bringing claims against Rolf Harris.

Under the administration of this absurd Scheme any allegation of "penile penetration", either of mouth or vagina, will automatically collect £11,000 for the claimant. See appendix B of the 2012 Act (B9) for the full scale of tariffs. Payment is made as a matter of "rite" and without requiring conviction. All done on the same basis that the Judge persuaded the Jury to convict Rolf .."The claimant must be believed".

We have descended into the abyss of medieval times in our hysteria for bringing conviction of any and all supposed sexual predators real or imagined. 



This is an opportunity to right a wrong in our domestic justice system. It would be right and proper to do so in England, rather than his lawyers take this to Strasbourg,


